Dear Taekwond Instructors,

Chicago's oldest Martial Arts School, which opened its doors in 1963, is pleased to invite you to compete in the Chicago Taekwondo championships on Sunday, December 15, 2012. Our new training facility is one of the largest in Chicago, measuring 12,500 square feet with a huge 50' x 85' continuous mat surface featuring eight 18' x 18' padded rings.

The tournament will feature Forms and Olympic Style Sparring. What is different about this tournament is that Color Belts will enjoy the same opportunity to compete generally given only to Black Belts. No more than 2 Color Belts will compete in the ring at the same time during Forms competition. All Black Belts will compete individually in Forms. The winners in each Black Belt division will compete for Grand Champion. All WTF, ITF, MDK and TSD traditional forms will be accepted. Medals will be awarded for first, second, and two third places,

In addition, all Color Belts will have two 60 second rounds with a 30 second break in Olympic Style Sparring. We encourage qualified coaches to assist their athletes. Black Belts will have two 90 second rounds. WTF rules will apply. All competitors are required to weigh in between 9:00 am and 10:15 am. Head, chest, forearm, shin and instep protectors, as well as mouth guards and groin protectors for males are mandatory.

Unlike most local tournaments, our tournament will really start on time so don't arrive late! If you have any questions, please feel free to contact me. I look forward to seeing you on December 15th for a quality event!

 Black Belts fight two 90 second rounds with 30 second break between rounds.
 Color Belts fight two 60 second rounds with 30 second break between rounds.
